MAKING AN APPROPRIATION FOR A STATE ARMORY AT GREENWICH.

Resolved by this Assembly: Section 1. That the sum of ten thousand dollars, or so much thereof as may be necessary, is hereby appropriated, in addition to the sums heretofore appropriated, to be paid out of any money in the treasury not otherwise appropriated, for the purpose of acquiring a site for and building a state armory in the town of Greenwich.

SEC. 2. Said site shall be acquired and said building erected under the supervision and direction of the acting quartermastergeneral.

AMENDING THE CHARTER OF THE ANSONIA WATER COMPANY.

Resolved by this Assembly: Section 1. That the resolution incorporating the Ansonia Water Company, approved July 9, 1864, be and it is hereby amended by substituting in the sixth line of the first section thereof in lieu of the words "public and domestic" the words "public, domestic, industrial, and general", so that said section as amended shall read as follows: That J. H. Bartholoniew, Geo. P. Cowles, D. W. Plumb, Thomas Wallace, Jr., Charles Durand, Robert Hoadley, Abm. Hubbell, Willet Bradley, Wm. B. Bristol, E. Peck, with all such persons as are or may be from time to time associated with them for the purpose of supplying the village of Ansonia and vicinity with an abundant supply of pure water for public, domestic, industrial, and general use, their successors and assigns be and they are hereby incorporated for said purpose by the name and style of the Ansonia Water Company, and by that name shall be and hereby are made capable in law to have, purchase, receive, possess, and enjoy, to them and their successors, lands, rents, tenements, hereditaments, goods, chattels, and effects of what kind and quality soever necessary to give effect to the specified purposes of this company, and for the accommodation of their business and concerns, and the same to sell, grant, demise, aliene, and dispose of, to sue and be sued, plead and be impleaded, defend and be defended in all courts in this state or elsewhere; to make and have a common

seal, and the same to break and renew at pleasure; also to make, ordain, establish, and put in execution such by-laws, ordinances, and regulations as shall be deemed necessary and convenient for the well-ordering and government of said corporation, not being contrary to this act and the laws of this state and of the United States; and to do and execute all and singular the matter and things which to them may or shall appertain to do, subject to the rules, regulations, and provisions hereinafter prescribed.

MAKING AN APPROPRIATION FOR THE CONNECTICUT INSTITUTE AND INDUSTRIAL HOME FOR THE BLIND.

Resolved by this Assembly: Section 1. That the sum of fifty thousand dollars be and hereby is appropriated to be paid out of any money in the treasury not otherwise appropriated, for the Connecticut Institute and Industrial Home for the Blind, for the purchase of land and the erection and furnishing of a building or buildings thereon suitable for carrying on the work of said institute.

- SEC. 2. The payment of said sum shall be made in two equal amounts, one in the year 1909 and one in the year 1910, and shall create a lien on the land and buildings so purchased and erected, which shall take precedence of any mortgage or other incumbrance thereon recorded subsequent to such payments, and said lien shall be foreclosed in behalf of the state if said land or buildings are ever diverted from the uses for which their acquisition is hereby authorized; and the comptroller shall cause this resolution, together with a description of such real estate, to be recorded in the land records of the town in which such real estate is situated, and such record shall be conclusive notice to all the world of the lien hereby created.
- SEC. 3. Any existing lien in favor of the state upon the real estate of the Connecticut Institute and Industrial Home for the Blind, located on the south side of Asylum avenue in the city of Hartford, known as numbers 1205 and 1207, is hereby released and discharged.
