AN ACT AMENDING THE MERIT SYSTEM ACT OF THE CITY OF NEW BRITAIN.

Vetoed August 12, 1955.

[House Bill No. 26.] [42.]

AN ACT AMENDING THE CHARTER OF THE GREENWICH WATER COMPANY.

SECTION 1. The Greenwich Water Company is authorized to supply water for public and private use in any city, municipality, town, borough or community, whether or not incorporated, located within the county of Westchester, state of New York, provided such use shall not curtail the abundant supply of water for the inhabitants of this state.

SEC. 2. Nothing contained in this act shall affect the power and authority of the attorney general under section 215 of the general statutes to negotiate and contract concerning the use,

allocation or diversion of waters from interstate streams, or any authority of the Greenwich Water Company to supply water pursuant to any such contract.

- SEC. 3. Any authority of the Greenwich Water Company to supply water in Westchester county, or any part thereof, or to the inhabitants of said county, or any part thereof, inconsistent with or more extensive than the authorization set forth in this act is repealed.
- SEC. 4. This act shall take effect from its passage as an amendment to the charter of the Greenwich Water Company and shall not require acceptance by said company.

AN ACT VALIDATING CERTAIN SALES BY THE TAX COLLECTOR OF THE TOWN AND CITY OF STAMFORD.

Any sale made by the tax collector of the town and/or city of Stamford for the purpose of collecting unpaid taxes of the town of Stamford and for the city of Stamford, or any sale in which more than one parcel was sold or conveyed in a single deed, or in which the taxes on each parcel were not separately mentioned or in which the sale of a part of any lot or parcel might have satisfied the taxes due thereon, or any sale in which the notice of the tax warrant was posted on the signpost and filed in the town clerk's office in less than nine weeks before the time of sale, or any sale in which the notice was published in a newspaper published in Stamford three times although such publication was not made once a week for three successive weeks, or any sale made by said tax collector in which any irregularity or omission appears either in the advertisement therefor or in the deed conveying the property, are hereby validated, provided such deed has been recorded in the land records of the town and city of Stamford for at least four years prior to the passage of this act and provided no civil action in which the validity of such sale or deed is in issue is pending on the date of the passage of this act.
