Resolved by this Assembly :-- That the said William T. Reynolds and Daniel W. Bartlett, trustees as aforesaid, be and they hereby are authorized and empowered to sell and convey by good and valid deed or deeds, in such manner and upon such terms as they shall deem for the best interest of the parties entitled to the beneficial interest in the same, the following described piece of land, the same being part of said estate, situated in said town of Orange, and bounded northerly on land of Samuel L. Smith and others; easterly on land of Hiram Smith; southerly on land of Edmund Dickerman and others, and westerly on Cove Meadow, so called ; the same being sixty-five acres, more or less, and upon such sale to invest the proceeds thereof in such first class securities as shall be approved by the court of probate within and for the district of New Haven; provided, however, that before any such sale shall be made of said land, bonds shall be given to the satisfaction of said court of probate for the faithful exercise of the powers hereby conferred, and binding the said trustees to use, apply, and duly account for, the proceeds of such sale and the income therefrom, in all respects, in accordance with the terms and requirements of said will of the said Alexis W. Painter, deceased, and to make return to said probate court of the time and manner of such sale, and the amount realized therefrom, as said court shall direct.

AMENDING THE CHARTER OF THE CITY OF MERIDEN.

UPON the petition of the board of water commissioners of the city of Meriden, showing that under the authority given them by the act amending the charter of the city of Meriden, approved July 24th, 1868, they have agreed to con-

struct, and are about to construct a certain reservoir in the town of Berlin, for the purpose of compensating the Hart Manufacturing Company, and other parties owning mills, mill sites and water privileges in said Berlin, which are to be damaged by the action of said commissioners in taking water for the use of said city of Meriden, which reservoir is fully described in said petition, and praying for authority to convey said reservoir when constructed, to the parties for whose compensation the same is to be constructed.

Resolved by this Assembly:-That said board of water commissioners of the city of Meriden are hereby authorized and empowered, when said reservoir shall have been constructed in pursuance of the eighth section of said resolution, to convey to said Hart Manufacturing Company, and other parties, for whose compensation said reservoir is to be constructed, and their successors, heirs, and assigns respectively, the right to maintain, control, and regulate said reservoir, and to control and regulate the use of the water stored thereby, for all purposes connected with the operation of their said mills, mill sites, and water privileges; provided, that the appraisers appointed under the eighth section of said resolution, shall be residents of the county where the land lies, and that there shall be added to the amount of compensation or damage awarded by said appraisers, fifty per centum as the sum to be paid for the damages arising in consequence of the taking under said section.
