part of the extensions herein authorized ; but the total fare for one continuous passage between any point on the present line of the company and the north end of Orange street, or the north end of View street, or Lyman street, shall not exceed eight cents, and the total fare for one continuous passage between any point on the present line of the company and the corner of Nickoll and Lawrence streets shall not exceed six cents.

Provided, That all tracks built under this resolution shall be located in said streets and constructed under the supervision and to the acceptance of the board of road commissioners of the city of New Haven.

And *provided also*, that nothing in this resolution shall authorize the laying or constructing of a track in any street alongside of any other track, nor in any part of any street where any other person is or at the time of constructing such track shall be authorized to lay a track, unless said company shall first obtain the written consent of said board of road commissioners to lay said track.

Approved, March 12, 1880.

An Act Amending the Charter of the City of Meriden.

Be it enacted by the Senate and House of Representatives in General Assembly convened: The court of common council of the city of Meriden may annually appoint some suitable person to act as watchman at and about the property of the city used as a reservoir for the water works, whose duties, compensation, and time of appointment may be fixed by said court of common council. Such person shall give bonds for the faithful performance of his duties, in such sum as the by-laws of said city shall prescribe, and shall, with respect to all offences committed on the property of the city used in connection with said water works, have all the powers which are conferred by law upon constables of the towns of Meriden and Berlin.

Validating Certain Acts of the Middlesex County Orphan's Home.

WHEREAS, Doubts have arisen as to the regularity and legality of the organization and transactions of The Middlesex County Orphans' Home, and a full and satisfactory explanation of the facts has been made: therefore,

Resolved by this Assembly: SECTION 1. That the meeting of corporators of said Home, held on December 15, 1879, be, and the same is hereby, declared a legal meeting, and the action of said meeting in (1) adopting a constitution, (2) adopting by-laws, (3) approving the work of those who had up to that time acted as officers, managers, and committees, (4) electing forty-nine additional corporators, (5) choosing forty managers for the term ending on the first Monday of December,
