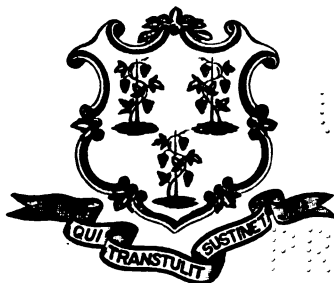

SEC. 5. Said corporation shall have power to hold meetings and elect officers and in such manner as its constitution and by-laws shall prescribe.

SEC. 6. Said corporation shall not hold, at any one time, real estate in this state the annual income of which shall exceed five thousand dollars, except lands taken as security for, or in payment of, debts to the corporation; and the net income of all the property held by said corporation shall be from time to time expended in furtherance of the objects of the corporation.

REIMBURSING ANDREW H. MUSSMAN FOR INJURIES RECEIVED WHILE  
IN THE SERVICE OF THE STATE.

*Resolved by this Assembly:* That the comptroller be and he hereby is authorized and directed to draw his order on the treasurer for the sum of seventy-five dollars in favor of Andrew H. Musseman of Manchester, in full compensation for injuries sustained by him while in the service of the state.

PROVIDING FOR THE ERECTION OF A HEADSTONE AT THE GRAVE OF  
JOHN HICKEY.

*Resolved by this Assembly:* That the acting quartermaster-general is hereby authorized and directed to cause to be erected at the grave of John Hickey, late of Company D, Twenty-second Regiment, Connecticut Volunteers, in St. Francis cemetery, at Providence, Rhode Island, a headstone of the material, design, and description set forth in section 2882 of the general statutes; the expense of said headstone, including the erection thereof, shall not exceed the sum of twenty dollars, and the comptroller shall draw his order on the treasurer for the amount of said expense as certified by the acting quartermaster-general.

AMENDING THE CHARTER AND EXTENDING THE TIME OF THE NEW-  
TOWN WATER COMPANY.

*Resolved by this Assembly:* SECTION 1. That section one of the resolution incorporating The Newtown Water Company, approved

May 18, 1893, is hereby amended by striking out in the second line of said section the name "Daniel W. Kissam" and inserting in lieu thereof the name "John J. Northrop."

SEC. 2. The time within which said corporation may organize, certify its organization to the secretary of the state, and exercise all other rights and privileges granted by said resolution is hereby extended to July 1, 1907.

[Substitute Bill for House Joint Resolution No. 282.]

AN ACT MAKING AN APPROPRIATION FOR THE EDUCATION OF THE DEAF AND DUMB FOR THE TWO YEARS ENDING SEPTEMBER 30, 1907.

*Be it enacted by the Senate and House of Representatives in General Assembly convened:*

Fifty-eight thousand dollars, or so much thereof as may be necessary, is hereby appropriated to be paid out of any money in the treasury not otherwise appropriated, for the support, care, and education of the deaf and dumb, under contracts made by the governor, for the two fiscal years ending September 30, 1907; provided, that the entire amount appropriated shall not exceed two hundred and fifty dollars per annum for each pupil.

[Senate Bill No. 223.]

AN ACT MAKING AN APPROPRIATION FOR THE CONNECTICUT AGRICULTURAL COLLEGE FOR THE TWO YEARS ENDING SEPTEMBER 30, 1907.

*Be it enacted by the Senate and House of Representatives in General Assembly convened:*

The following sum is hereby appropriated to be paid out of any money in the treasury not otherwise appropriated, in full compensation for the objects hereinafter specified for the two fiscal years ending September 30, 1907: For The Connecticut Agricultural College, for the improvement of land, repairs of buildings and equipment, erection of minor buildings, insurance, and other necessary purposes, forty thousand dollars.
