

To the Honorable Genl. Assembly of the State of Connecticut  
 to be holden at Hartford on the second Thursday  
 of May AD 1800 The Petition of the Windsor Aqueduct  
 Company by James Hooker their Agent humbly  
 sheweth That a Resolue of the General  
 Assembly of the State of Connecticut at their  
 Session on the 2<sup>d</sup> Thursday of May AD 1798 James  
 Hooker Alex Wolcott and Josiah Bissell with their  
 Associates were incorporated into a Body politial  
 by the name of Windsor Aqueduct Company with  
 power of forming and completing an Aqueduct  
 to convey Water from the Land of Levi Hayden  
 about one Hundred Rods to the Westward of the now  
 dwelling house of said Levi along the Highway  
 to the dwelling house of Elisha Strong in such  
 manner that each Member of sd Company may  
 be supplied with Water - And with various  
 other Corporate Powers for the regulation of said  
 Aqueduct - And sd James Hooker in behalf of  
 sd Company informs your Honours that agreeable  
 to the sd Resolue of Assembly said Stream of Water  
 has been conveyed along the highway from said  
 Haydens Land to the dwelling house of sd Strong  
 but the quantity of Water is found insufficient  
 to supply all the Members of sd Company - And he  
 would further inform that there is Water on the  
 Lands of Azariah Chaffer Jun<sup>r</sup> & Lemuel Welch at  
 Sandy Hill so called which may be so connected  
 with the Tube conveying the Water from sd Haydens  
 Land as to insure a sufficient quantity for each  
 member of sd Company - And that sd James Hooker

prays your Honours to empower D Windsor Aqueduct  
 Company to convey the Water from D Sandy Hill &  
 connect the same with the original Aqueduct And  
 also that the branch from Sandy Hill be considered &  
 become a part of D Aqueduct <sup>and that</sup> in the same manner  
 the D Company have the power of forming complet  
 ing repairing and regulating the branch of Aqueduct  
 to convey Water from D Sandy Hill as they had by D resolved to form  
 complete repair and regulate the original Aqueduct conveying Water from the Land of D Hayden  
 And your Honours as in duty bound shall see  
 may Windsor May 10th 1800
