SECT. 6. The number of members of said corporation shall not Members limitexceed one hundred at any one time. Any number not less than seven shall constitute a quorum for the transaction of business at the annual and other meetings of the members of said corporation, provided that such meetings shall have been duly notified in conformity to the by-laws of said corporation, and provided further that said corporation may, by their by-laws, require the attendance of one or more of their officers, by them designated, to constitute a quorum for the election of members in addition to the number of members hereinbefore prescribed.

SECT. 7. Said corporation shall have power to make such by-laws Power to make as are necessary and proper for the management of the affairs of by-laws. the institution, provided, however, that they are not repugnant to the constitution and laws of the state.

SECT. 8. John L. Perley, Warren Lovell and Benjamin P. Gale, First meeting, how called. or any two of them, are hereby authorized to call the first meeting of said corporation, by giving personal notice to the corporators herein named of the time and place of said meeting at least ten days before the time of said meeting.

SECT. 9.
