§ 2. This act shall take effect immediately.

Chap. 550.

AN ACT to amend the act to incorporate the Attica Water-works Company, passed May sixth, eighteen hundred and seventy.

Passed April 19, 1871; three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

SECTION 1. The twenty-fifth section of the act to incorporate the Attica Water-works Company, passed May sixth, eighteen hundred and seventy, is hereby amended so as to read as follows :

§ 25. Whenever the said Attica Water-works Company shall increase the capital stock of said company to the amount of twenty thousand dollars in accordance with the provisions of said act, then the trustees of the said village of Attica are hereby authorized for and in behalf of the corporation of said village, to take and invest in the stock of the said Attica Water-works Company, to an amount not exceeding fifteen thousand dollars, provided they shall be so authorized by a vote of the taxable electors of said village, at an annual or at a special meeting called as hereinafter provided. The trustees of said village are hereby authorized to call a special meeting of the electors of said village, at any time on the written request of twelve tax-paying freeholders of said village, for the purpose of voting on the question of taxing and investing as in this section mentioned. A notice of the time and place of holding such meeting shall be published in the newspapers published in said village for two weeks previous to said meeting successively. The said trustees shall have power to issue the bonds of said village payable twenty years after date,

Chap. 551.

AN ACT to amend an act entitled "An act to legalize orders made by county judges in certain cases," passed April thirteenth, eighteen hundred and sixty-five.

Passed April 19, 1871; three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

SECTION 1. "An act to legalize orders made by county judges in certain cases," passed April thirteenth, eighteen hundred and sixty-five, is hereby amended so as to read as follows:

Every order for the service of a summons, in a civil action, by publication, made by a county judge prior to the first day of January, eighteen hundred and seventy, shall have the same force and effect as though such order had been made by the court in which the action was commenced, or by a justice of the Supreme Court.

§ 2. This act shall take effect immediately.

Chap. 552.

AN ACT authorizing Susanna Newbould to hold and convey real estate.

Passed April 19, 1871, by a two-third vote.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

SECTION 1. Susanna Newbould, wife of John A. Newbould of the city of Brooklyn, in the county of Kings, is hereby authorized to take, by descent, gift, grant, devise, or otherwise, real property in this State, and the
