Upon breach of any of said conditions, the commissioners of said square shall have full authority to enter upon said premises and assert their right to and authority over the same, and they may take all such proceedings at law or in equity, as may be proper and necessary to assert and establish their right and title thereto.

§ 4. This act shall take effect immediately.

### CHAP. 408.

AN ACT to authorize the board of water commissioners of the village of Middletown to grant permits for the taking of ice from Monhagen reservoir.

PASSED June 4, 1877; three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Taking of ice may be permitted by commissioners.

SECTION 1. The board of water commissioners of the village of Middletown may grant to any person, persons or company the privilege of taking ice from Monhagen reservoir on such terms as will be most advantageous to said village.

§ 2. This act shall take effect immediately.

### CHAP. 409.

AN ACT to authorize the trustees of the corporation of the village of Portageville, county of Wyoming, to cause an assessment to be made of the taxable property of said corporation and to be levied and collected a tax sufficient to pay the indebtedness of said corporation.

Passed June 4, 1877; three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Assessors, authorizing appointment of, etc.

SECTION 1. The trustees of the corporation of the village of Portageville, to wit: Robert Rae, Marvin Wood, Peter Bradley, William Mosher and William A. Kerns are hereby empowered and authorized to appoint three assessors, inhabitants and tax payers of said corporation, whose duty it shall be to assess the taxable property of said corporation, within a reasonable time after their appointment, and deliver the same to the trustees of said corporation.

Application of funds. § 2. The trustees of said corporation, Robert Rae, Marvin Wood, Peter Bradley, William Mosher and William Kerns, are hereby authorized and empowered to cause to be assessed and levied of the taxable property of said corporation a sum sufficient to pay the indebtedness of said corporation, not to exceed the sum of six hundred dollars, and to issue their warrant to the collector of said corporation (in the usual form), directing said collector to collect of the property so assessed the sum so to be raised, and to pay over to the treasurer of said corporation all moneys so collected, and when the moneys are so collected and in the
