



Proviso. Assent of commissioners of Columbia.

342

Drafts filed with clerks of quarter sessions.

Pay of commissioners, with allowance for assistants. of Big Roaring creek, from thence up the said creek to Yarnall's Path, thence a south-easterly course to the county line: *Provided*, That the county commissioners of Columbia county shall first express in writing. their assent to the provision of this and the two succeeding sections of this act.

SECT. 2. And be it further enacted by the authority aforesaid, That as soon as the said line is run, marked, and fixed, a draft thereof, with the courses and distances, shall be made and filed by said commissioners in the office of the clerk of the court of quarter sessions of Columbia and Northumberland counties.

SECT. 3. And be it further enacted by the authority aforesaid. That the said commissioners shall be allowed two dollars each for every day necessarily employed in performing the duties mentioned in the first section of this act. together with a reasonable allowance for chain carriers, and markers, to be paid equally by the counties aforesaid, by orders drawn by the commissioners of said counties, on their respective treasurers, in the usual manner.

A SUPPLEMENT

To an act entitled "An act authorising the Governor to incorporate the Northampton water company," and to continue in force an act entitled "An act to incorporate the York manufacturing company."

Sucr. 1. Be it enacted by the Senate and House of Representatives of the commonwealth of Pennsylvania in general assembly met, and it is hereby enacted by the authority of the same, That all transfers of the stock of the Northampton water thampton water co. That all in presence of and attested by the president, treasurer or secretary of said company, and no transfer

of said stock hereafter made in any other manner, shall entitle the person receiving such transfer to the privileges of a stockholder in said company, and all transfers heretofore made according to the provisions of the act to which this is a supplement, may be recorded in said book.

SECT. 2. And be it further enacted by the authority aforesaid, Acts to in-That the act entitled "An act to incorporate the York corp. York manufacturing company," approved the twenty-eighth manufacturing & Tioga day of March, one thousand eight hundred and twenty, navigation and an act incorporating the Tioga navigation company. companies passed twentieth February, one thousand eight hundred continued and twenty-six, together with the supplement thereten years. to, be and the same hereby are revived, perpetuated and continued in force, to all intents and purposes, for the space of ten years from and after the twenty-eighth day of March, one thousand eight hundred and thirty.
