## AN ACT

Repealing a part of the first section of an act, entitled "A further supplement to an act providing for the introduction of water into the borough of Lebanon," approved the eighth day of April, one thousand eight hundred and seventy-three, said act being a supplement to an act approved the fifteenth day of April, Anno Domini one thousand eight hundred and sixty-nine, entitled "An act providing for the introduction of water into the borough of Lebanon."

Repeal.

SECTION 1. *Be it enacted, &c.*, That so much of section first of an act, entitled "A further supplement to an act providing for the introduction of water into the borough of Lebanon," approved the eighth day of April, Anno Domini one thousand eight hundred and seventy-three, which authorizes the burgess and council of said borough to levy and assess a yearly frontage tax upon lots fronting on streets through which water mains are or shall be laid, upon which there is no building erected or built, be and the same is hereby repealed, said act being a supplement to an act approved the fifteenth of April, Anno Domini one thousand eight hundred and sixty-nine, entitled "An act providing for the introduction of water into the borough of Lebanon."

## A SUPPLEMENT

To an act, entitled "An act for the regulation and government of the Northampton county prison," approved the tenth day of May, Anno Domini one thousand eight hundred and seventy-one.

Salary of secretary to prison inspectors.

SECTION 1. *Be it enacted, &c.*, That hereafter the secretary of the board of inspectors of the Northampton county prison, shall receive for his services as inspector and officer not more than the sum of one hundred and fifty dollars per annum.
